1. Approval of the Agenda/Additional Items

The meeting was called to order at 9:00 a.m. B. McEwen welcomed everyone to the meeting on behalf of BCBEC. The May 20, 2009 BRC meeting agenda was approved.

2. Approval of November 27, 2007 Meeting Minutes

The minutes from the November 26, 2008 BRC meeting were approved.

3. Mid-rise Wood Frame Construction Bulletin and Wood Frame Best Practice Guide

D. Ricketts reviewed some of the structural, fire and envelope issues that require consideration in these buildings. He informed the committee that the APEGBC Technical and Practice Bulletin on six-storey wood frame construction is now available on the APEGBC website. As well, APEGBC will be hosting a one day conference June 15, 2009.

The Best Practice Guide on Wood Frame Envelopes is in the process of being updated and is scheduled for release spring 2010.

4. Wood Frame Building Shrinkage Measurement

B. McEwen expressed concern regarding the lack of information available on the measurement of shrinkage in wood frame construction. B. McEwen proposed that these issues be researched and perhaps be addressed in the update of the Wood Frame Best Practice Guide.

5. Energy Consumption in High-rise Rehabilitated Buildings

W. Knowles provided an update on the status of the research study on energy consumption in high-rise rehabilitated buildings. He noted that energy use in newer buildings was not decreasing as might be expected, perhaps due to gas fireplaces, more glazing and lack of local gas metering.

6. Building Code related CSA 080 Standard on Wood Preservation

P. Morris provided highlights of the proposed new requirements for 2010 to Building Code related CSA 080 Standard on wood preservation. Discussion included marking details, use categories and third party quality assurance.

D. Ricketts recommended that these changes be included in the new HPO Wood-frame Guide.

M. Frank noted that builders, suppliers and building officials need education regarding the compatibility of fasteners and connectors used with ACQ treated wood. As well, there is a lack of information on where to get borate and borate treated wood.

7. CSA 440.4 Windows Standard and National Certification Program

C. Gould noted that the CSA 440.4 Windows Standard and National Certification Program contradicts Part 9 of the BC Building Code. Discussion ensued.

S. Plescia and B. Hubbs suggested that the CSA 440.4 Committee reconvene on this matter.

8. Building and Safety Policy Branch – Update on Future Initiatives

B. Thompson provided an update on future initiatives in regards to the following projects: Greening of the BC Building Code, EnerGuide 80 for Houses and energy use targets in BC Building Code – Part 9.

9. Polyurethane Waterproofing Membrane Update

B. Hubbs presented an initial finding that the potential cause of blistering of polyurethane waterproofing membrane is an osmosis mechanism.

10. BCIT Field Testing Facility

F. Tariku gave an update on the field monitoring of the BCIT Field Testing Facility. As well he spoke to current testing being done and BCIT capabilities for research.

11. CMHC Equilibrium Projects in British Columbia

A. Dobie provided an update on two new CMHC Equilibrium projects in British Columbia. Further information regarding CMHC Equilibrium projects and energy-efficient technologies can be found on the CMHC website. A. Dobie will present a PowerPoint at the next BRC meeting.

12. Recently Completed or Current Research Projects CMHC

- S. Plescia provided an update of current CMHC projects, including:
 - BCIT's Wind-driven Rain Study in the Coastal Climate of British Columbia has been completed. Final Report will be made available on the CMHC website.
 - MURBS Toronto initiated a tower renewal energy performance study.
 - Window Best Practice Guide expected to be completed by summer.
